Single¹ Grave (Plot): Total \$500.00

Two (2) Graves (Plots): Total \$1000.00

Four (4) Graves (Plots): Total \$2000.00

Eight (8) Graves (Plots): Total :4000.00

Interments

Regular Human Interment - Total: \$650.00

- No Vault: **Add \$300.00**
- Holiday & Weekend: **Add \$300.00**
- Winter Opening: **Add any incurred expenses**

Infant Interment – Total: \$550.00

- No Vault: **Add \$300.00**
- Holiday & Weekend: **Add \$300.00**
- Winter Opening: **Add any incurred expenses**

Cremation Interment – Human & Pets²

- **2nd Right of Interment Fee – Total: \$250.00** When any cremation (human or pet) burial is to be placed on a purchased and occupied plot, there will be a 2nd Right of Interment fee charged.
- **Cremation Interment - No Vault – Total: \$300.00**
- **Cremation Interment - With Vault – Total: \$400.00**
- Holiday & Weekend: **Add \$300.00**
- Winter Opening: **Add any incurred expenses**
- Up to four (4) non-vaulted cremated remains can be placed on one plot.
 - A 2nd Right of Interment fee will be charged per cremated inurnment.
 - Casketed remains won't be placed after cremated remains.

2nd Right of Interment Fee – Add \$250.00

Dual Interments

When a cremated body is inurned, at the same time, in the same location, as one full body, or one cremated body, a 2nd Right of Interment/Inurnment Fee will be charged in addition to one Regular Human Interment or Cremation Inurnment Fee.

Pet² Cremated Remains

Pet² Dual Inurnment – Add \$250

When an owners' cremated pet remains are inurned, at the same time, and in the same location, as the pet owners' full body, or cremated remains, a Dual Inurnment Fee will be charged in addition to one Regular Human Body, or Human Cremated Remains Interment Fee.

Pet² Inurnment – Add \$250

2nd Right of Interment Fee – When an owners' Pet cremation burial is to be placed on a purchased and occupied Owners' plot, there will be a 2nd Right of Interment fee charged in addition to the Cremation Interment Fee.

Burials are not conducted on the following Holidays:

New Year's Eve/Day, Easter Sunday, Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas Eve/Day.

Memorialization without Interment/Inurnment

Memorialization's without interment/inurnment involve payment of charges such as, the purchase of a plot, foundation installation charges and any other applicable fees. Other restrictions may apply.

Foundation Installations & Repairs

Monument Foundation Installation - \$1/sq. in.

Paid directly to the Service Provider.

Monument Foundation Repairs - \$1/sq. in.

Paid directly to the Service Provider.
